AWARDS NOMINEE QUALIFICATIONS

REALTOR OF THE YEAR - Nominee must demonstrate:

- (a) Contributions toward REALTOR spirit, local Association activity, faithfulness to principles, organization ethics and promotion of professionalism.
- (b) Activity in local, State and National Association.
- (c) Commitment to education through courses attended and Designations earned.
- (d) Civic and community involvement and services.

AFFILIATE OF THE YEAR - Nominee must demonstrate:

- (a) Contribution toward REALTOR spirit- Efforts to promote professional practices in dealing with REALTORS and co-Affiliates, Association and committee work, etc.
- (b) Business Accomplishments- Services to REALTOR clients, conduct of education sessions, dissemination of information, etc.
- (c) Contribution toward further education of the real estate industry within their field of expertise.
- (d) Civic and Community involvement-Participation in service clubs, charitable causes, political action, and fraternal groups.

CITIZEN OF THE YEAR - Selection will be based on the nominee's contribution of service to the public as a public official (elected or appointed), educator, business professional, philanthropist, etc.

ROOKIE OF THE YEAR - This award is based on a combination of service to the community and REALTOR organization, and a level of business that indicates future success as a REALTOR (indicating a future longevity in the business), as well as courses attended and designations earned. His/her real estate practice must have begun within the past sixteen (16) months.

REALTOR LIFETIME ACHIEVEMENT- must have a minimum of 25 years as a REALTOR; have held leadership positions in local association during that time; be active in the business of real estate at this time.

PARTNER OF THE YEAR-News media, Community Activist Group- Selection will be based on community affairs support of REALTOR issues and support of REALTOR® efforts overall. Use narrative format, provide details (including dates) and attach any additional exhibits.

COMMUNITY SERVICE- based on outstanding contributions of a REALTOR® to their local community, as well as being active professional member of local association. Current accomplishments and/or accomplishments from prior years.
